Categories of citizens exempt from paying the resort fee

(as of 1 March 2024)

- 1) Individuals awarded the titles of Hero of the Soviet Union, Hero of the Russian Federation, or Full Cavaliers of the Order of Glory
- 2) Individuals awarded the title of Hero of Socialist Labour or Hero of Labour of the Russian Federation, or awarded the Order of Labour Glory of three classes
 - 3) Participants of the Great Patriotic War
- 4) Veterans of combat actions among individuals listed in subparagraphs 1–4 of paragraph 1 of Article 3 of Federal Law No. 5-FZ of 12 January 1995, "On Veterans", namely:
- Military personnel, including those retired to reserve (dismissed), conscripts, called up for military training, personnel of the rank and file and commanding staff of internal affairs bodies, troops of the national guard, and bodies of state security, employees of said bodies, employees of the Ministry of Defence of the USSR and the Ministry of Defence of the Russian Federation, employees of institutions and bodies of the penal correctional system, bodies of enforcement of the Russian Federation, dispatched to other states by the bodies of state authority of the USSR, bodies of state authority of the Russian Federation, and who participated in combat actions while performing official duties in these states, as well as those who participated in combat actions on the territory of the Russian Federation in accordance with decisions of the authorities of the Russian Federation
- Military personnel of the Federal Security Service bodies, including those retired to reserve (dismissed), who performed tasks to repel armed invasion of the territory of the Russian Federation, as well as during an armed provocation on the State border of the Russian Federation and adjacent territories of the subjects of the Russian Federation bordering the areas of the special military operation in the territories of Ukraine, Donetsk People's Republic, and Luhansk People's Republic since 24 February 2022
- Military personnel, including those retired to reserve (dismissed), personnel of the rank and file and commanding staff of internal affairs bodies and bodies of state security, individuals who participated in operations in carrying out governmental combat tasks for demining territories and objects on the territory of the USSR and territories of other states from 10 May 1945 to 31 December 1951, including operations for combat mine clearance from 10 May 1945 to 31 December 1957
- Individuals who, in accordance with decisions of the executive authorities of the Republic of Dagestan, participated in combat actions as part of self-defence units of the Republic of Dagestan during the period from August to September 1999 during counter-terrorist operations on the territory of the Republic of Dagestan
- Individuals who joined voluntary formations established by the decision of the bodies of state authority of the Russian Federation assisting in fulfilling tasks assigned to the Armed Forces of the Russian Federation (troops of the national guard of the Russian Federation) during the special military operation in the territories of Ukraine, Donetsk People's Republic, and Luhansk People's Republic since 24

February 2022, as well as in the territories of Zaporozhye Region and Kherson Region since 30 September 2022

- Individuals who, in accordance with decisions of the authorities of the Donetsk People's Republic, Luhansk People's Republic, participated in combat actions as part of the Armed Forces of the Donetsk People's Republic, People's Militia of the Luhansk People's Republic, military formations, and bodies of the Donetsk People's Republic and Luhansk People's Republic starting from 11 May 2014
- Individuals who entered into contracts (or had other legal relationships) with organizations assisting in fulfilling tasks assigned to the Armed Forces of the Russian Federation during the special military operation in the territories of Ukraine, Donetsk People's Republic, and Luhansk People's Republic since 24 February 2022, as well as in the territories of Zaporozhye Region and Kherson Region since 30 September 2022
- Military personnel of motor battalions dispatched to Afghanistan for cargo delivery during the period of conducting combat actions there
- Military personnel of flight crews making flights from the territory of the USSR for combat missions in Afghanistan during the period of conducting combat actions there Individuals dispatched to ensure the fulfillment of tasks during the special military operation in the territories of Ukraine, Donetsk People's Republic, and Luhansk People's Republic since 24 February 2022, who completed the established period of dispatch or were prematurely recalled for valid reasons
- 5) Individuals awarded the "Resident of Besieged Leningrad" badge, individuals awarded the "Resident of Besieged Sevastopol" badge
- 6) Individuals who worked during the Great Patriotic War on objects of anti-aircraft defence, local anti-aircraft defence, construction of defensive structures, naval bases, airfields, and other military facilities within the rear boundaries of active fronts, operational zones of active fleets, on pre-frontline sections of railways and highways, as well as members of transport fleet crews interned at the beginning of the Great Patriotic War in ports of other states
 - 7) Disabled war veterans
- 8) Family members of deceased disabled war veterans, participants of the Great Patriotic War and combat veterans, family members of those who died in the Great Patriotic War among the personnel of self-defence groups of object and emergency teams of local anti-aircraft defence, as well as family members of deceased employees of hospitals and clinics in the city of Leningrad
- 9) Individuals affected by radiation as a result of the Chernobyl NPP disaster, as well as due to nuclear tests at the Semipalatinsk test site, and persons equated to them
 - 10) Disabled persons of Groups I and II
- 11) Individuals accompanying disabled persons of Group I and disabled children in accordance with the Federal Law of 17 July 1999 No. 178-FZ "On State Social Assistance"
- 12) Low-income families, low-income individuals living alone, and other categories of citizens provided for by the Federal Law of 17 July 1999 No. 178-FZ "On State Social Assistance", who have a per capita income below the subsistence

minimum established at their place of residence in the respective subject of the Russian Federation

- 13) Individuals arriving in the experiment territory for the purpose of receiving specialized, including high-tech, medical care or medical rehabilitation after receiving specialized, including high-tech, medical care in sanatoriums and resorts, as well as accompanying persons in case the patient is a child under 18 years of age
 - 14) Tuberculosis patients
- 15) Individuals under the age of 24 who are studying full-time at educational institutions located in the experimental territory
- 16) Individuals permanently employed in the experimental territory under an employment contract or official contract
 - 17) Individuals residing in the experimental territory
- 18) Individuals who own residential houses (shares in ownership thereof) and/or residential premises (shares in ownership thereof) in the experimental territory
- 19) Athletes, coaches, sports judges, as well as other specialists in the field of physical culture and sports, arriving to participate in official sports events in the experimental territory
- 20) Individuals specified in subparagraph 9 of paragraph 1 of Article 3 of the Federal Law "On Veterans"
- 21) Individuals who are members of families (incomplete families) with three or more children (including adopted children under guardianship or trusteeship) under the age of 18
